

Introduction – Then & Now

SUPREME COURT
SINGAPORE

- Access to Justice as a cornerstone.
- Present position in Singapore:
 - 2006: Singapore Judiciary cleared 375,000 existing matters – clearance rate: 99%
 - 2007: Supreme Court cleared 8,319 cases while 8,046 cases were filed – clearance rate: 103%
 - No backlog of cases
 - Supreme Court: at least 85% of writ actions are disposed of within 18 months of filing



Introduction – Then & Now

SUPREME COURT
SINGAPORE

- Early 1990s:
 - Massive backlog of cases
 - In Supreme Court, more than 2,000 pending cases set down for trial, but trial dates 3 years or more after set down
 - More than 10,000 inactive cases, some more than 10 years old
 - About 44% of cases took between 5-10 years from commencement to disposal
 - Appeals took 2-3 years to be heard



Introduction – Then & Now

SUPREME COURT
SINGAPORE

- Problem tackled by:
 1. Appointing more judges;
 2. Changing rules of procedure;
 3. Denying adjournments;
 4. Giving hearing dates to moribund cases;
 5. Expanding jurisdiction of subordinate courts.



Introduction – Then & Now

SUPREME COURT
SINGAPORE

- Result:
 - Backlog for High Court: reduced from 2,059 in 1991 to 175 cases in 1993
 - Backlog for Court of Appeal: reduced from 275 appeals in 1991 to 71 appeals in 1993

Monitoring to Prevent Impending Backlogs

Clearance Rates

No. of pending matters disposed of as a percentage of no. of new matters filed

Monitor clearance rates for individual categories of cases also

Disposal Timelines

Lifespan of cases (how long each case takes to clear system)

85% cases disposed of within 18 months from filing

Trial Date Availability

8 weeks between set-down and trial

Ensure trial dates are not too far in the future
